Written requests for jury instructions, with supporting authorities as are necessary, must be filed no later than two (2) weeks prior to the first scheduled trial date.

Trial Briefs: **Optional** in *Jury* cases; **Mandatory** in *Bench* cases and must be filed no later than two (2) weeks prior to the first scheduled trial date.

JURY TRIAL VOIR DIRE:

All jury voir dire must be conducted in conformity with Mecosta/Osceola Counties Policy/Procedure 2014-02, “Circuit Court, Probate Court and District Court Jury Voir Dire.”
