**MOTION DEADLINES:** All motions must be filed not later than \_\_\_\_ days after the conference/after filing of the preliminary examination transcript. If the preliminary examination transcript is not ordered within fourteen days following the conference, the motion is required to be filed by the preceding sentence, must be filed not later than \_\_\_\_ days following the conference. Motion briefs are **mandatory** and must be filed within the time periods set by court rule.

**JURY INSTRUCTIONS/TRIAL BRIEFS:**
